Cancellation policy

When cancelling within 8 weeks of start of the programme, 50% of the tuition and housing fee will be charged / When cancelling within 4 weeks of start of the programme, 75% of the tuition and housing fee will be charged / When cancelling within 2 weeks of the start of the programme, 100% of the tuition and housing fee will be charged.

Compulsory insurance requirements

Agreement for the Participation in CBL International Schools



CBL International

I, (your name) _____, an applicant for a CBL International School (hereinafter "programme"), hereby agree as follows:

1. All courses are conducted in English. I understand that I need to have sufficient English language skills to be able to understand the courses fully.
2. Because there is a limitation of the number of participants for CBL International Schools, my application is binding after confirmation.
3. I understand that in a foreign country I will be subject to the laws of that country. I agree to comply with those laws, including refraining from using, possessing or selling any illegal drugs. I understand that possession of any illegal drugs is grounds for immediate expulsion from the programme, without refund. In addition, I understand that should I have any legal problems in the host country, I will be responsible for any legal costs incurred as a result. CBL International cannot provide legal counsel in such circumstances.
4. CBL International strongly recommends against owning or operating motor vehicles (including motorcycles, mopeds, and all other motorized vehicles, as well as cars) while being abroad, due to the inherent dangers of driving in a country with different traffic laws, driving habits, and regulations relating to insurance. If, however, I decide to operate a motor vehicle while abroad, I recognize that CBL International or its agents or employees assume no responsibility for my safety and for costs or difficulties that I may incur, and that I participate in these activities at my own risk.
5. I understand and acknowledge that there are inherent health risks associated with traveling abroad. I agree that I am personally responsible for obtaining all health information, instructions, medical procedures, immunizations and medications appropriate to my intended travel. I recognize that CBL International is not responsible for any of my medical or medication needs and I assume all risk and responsibility therefore. I further agree that if I become incapacitated, CBL International, through its agents and employees, may take whatever action is deemed necessary with respect to my health and safety. I authorize CBL International, its agents and employees to place me, at their discretion and without my further consent, in a hospital or in the care of a local doctor for medical services and treatment. If necessary or desirable, I also authorize them to transport me back to my home country by commercial airline or otherwise for medical treatment. I agree that I will be fully responsible for any and all expenses, including transportation costs, associated with or in any way related to my medical care.
6. I understand that CBL International strongly recommends that I visit a travel clinic/doctor to receive additional, country-specific health and travel information.
7. I understand that if I engage in recreational activities, sports, tours, travel, or any other activities as part of the programme or during free-time and outside of organized programme activities that CBL International or its agents or employees assume no responsibility for my safety or any liability for costs or difficulties that I may incur, and that I participate in these activities at my own risk.
8. I agree that in the event that I become detached from the group due to failure to meet the group at an assigned time, I will bear all responsibility to seek out, contact, and reach the group at its next available destination and I understand that I will bear all the costs involved in contacting and reaching the group.
9. I understand that CBL International reserves the right to make cancellations, changes or substitutions in the programme at anytime because of emergency, changed conditions or the Programme Director's determination that such changes or substitutions are in the best interest of the programme or its participants. I understand that CBL International is not responsible for the cost of replacing airline tickets if the carrier goes into bankruptcy.
10. I understand that if my participation in the programme is terminated by the Programme Director, I will be dismissed with no refund of fees. If I am dismissed before completion of the Programme, I agree that I will be responsible for any and all costs and expenses associated with my return home, and that I will also be responsible for my own travel arrangements at home. I also understand that if I leave the programme voluntarily for any reason, including illness, I will be responsible for any and all costs and expenses associated with my return home and that there will be no refund of any fees.
11. I understand that if this programme contains an alcohol-related cultural event, that this event is not compulsory, and that I will be solely responsible for any injuries or property damage arising in relation to my participation in the event.
12. I understand that engaging in a political activity in the host country, including but not limited to joining political parties or unions, participating in demonstrations, soliciting political material or picketing may be dangerous or illegal. If I have legal problems because of such activities, I understand that CBL International cannot provide legal counsel.
13. I understand that there are unavoidable risks in study and travel outside my home country, and I hereby release and promise not to sue on behalf of myself, my heirs, executors, administrators and assigns, CBL International, or its employees, officers, regents and agents, for any damages or injury (including death) caused by, derived from, or associated with my participation in the programme, except for such damages or injury as may be caused by the gross negligence or willful misconduct of the employees, officers, regents and agents of CBL International. It is my express intent that this release shall bind the members of my family and spouse if I am alive, and my heirs, executors, administrators and assigns if I am deceased, and shall be deemed as a Release, Waiver, Discharge, and Covenant Not to Sue the above-mentioned parties.
14. I agree that, should any provision or aspect of this agreement be found to be unenforceable, all remaining provisions of this agreement will remain in full force and effect.
15. I agree to receive information updates before, during and after the course from CBL International Management Ltd. CBL International Management Ltd. is entitled to give partners (e.g. companies, law firms, institutions, media, etc.) access to the alumni network.
